**2.3. Financial Information:** If applicable, we may collect financial information, such as payment details, for billing and payment processing purposes.

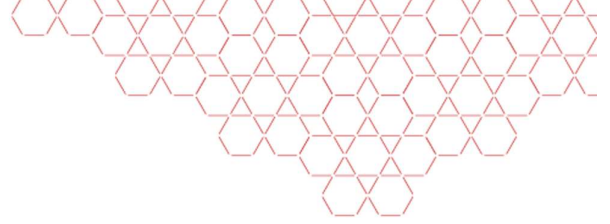

**5.1. Opt-Out:** You can opt out of receiving marketing communications from us by following the unsubscribe instructions in our emails.

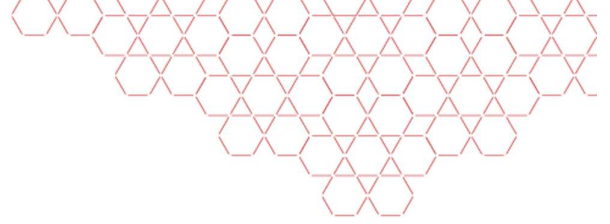
**5.2. Cookie Management:** You can control and manage cookies through your browser settings. However, disabling cookies may affect certain features and functionality of our website.
